

## MDA lobbies for “Montana Action for Dental Health” in 2017 Legislature

When the 2017 Legislature convenes on January 2, it will be taking up MDA’s “Montana Action for Dental Health”, a package of MDA-sponsored legislation to protect dental practices and improve access to oral health. Other issues impacting dentistry are also on MDA’s radar. In all, 2017 will be the most important session for dental advocacy in recent MDA history.

“MDA’s legislative agenda can be successful with the help of dentists across the state taking time to lobby their legislators,” said Dr. Jane Gillette, MDA president. “This is a tremendous opportunity to advance dentistry’s interests and MDA cannot do it without a strong core of grassroots advocates.”

“I urge MDA members to come to Helena on Friday, January 27 for MDA’s Dental Day at the Legislature,” she said. “Your face-to-face conversation with your local legislators can make the difference in ensuring their support for MDA’s positions.”

Here’s a summary of key legislation with direct impact on dentistry. (Until they are introduced bills are identified with an “LC” number.)

### General supervision for dental assistants

(LC0785) – MDA legislation requested by Sen-Elect Steve Fitzpatrick (R-Great Falls)

Why it’s important: MDA has drafted a bill to allow dentists to delegate some functions to dental assistants under general supervision. Currently, all dental assistant functions must be delegated under direct supervision. Under MDA’s bill, the Board of Dentistry would determine by rule which functions will be allowed under general supervision. This can expand access to care when the dentist is not present in the practice.

**Anesthesia mandate** (LC0528) – MDA legislation sponsored by Sen. Mary Caferro (D-Helena)

Why it’s important: MDA is preparing legislation mandating third-party coverage for anesthesia services for dental treatment for young children and the disabled in hospitals and other operating room facilities. Currently most insurance policies will cover anesthesia for other medical treatment, but not medically necessary dental treatment. This is a barrier to care. If you have information

## MDA member initiative to support dentists in quality documentation

In this year's ADA House of Delegates, Montana dentists led an initiative to direct the ADA to develop resources to support dentists in improving clinical documentation and Medicaid compliance. Specifically, the resolution stated:

*"Resolved, that the appropriate ADA agencies develop a resource guide which contains sample chart entries for the 30 most common procedure codes and additional guidance on best practices which relates to documentation which supports Medicaid Compliance for use by dentist members."*

The concept behind this resolution, which was referred to an ADA council for further consideration, originated within the MDA's Council on Dental Public Health and Health Planning. The Council is chaired by Dr. Jason Tanguay (Bozeman), the Sixth District member of the MDA Board of Directors and also includes Drs. Ron Jarvis (Kalispell), Jazmin Nelson (Missoula), Maria Bartoletti (Butte), Garry Pitts (Polson), Reed Thompson (Kalispell). Dr. Tanguay, who was present at the ADA House, testified on behalf of the resolution.

This resolution is significant for dentists as descriptive, supportive, and accurate documentation of procedures and care within dental charts is essential in protecting dentists in the event of litigation or an audit. Inadequate documentation of diagnosis, clinical findings, and procedures performed can result in legal cases which are difficult to defend and in the case of a Medicaid audit, large recovery payments by the dentist to the state Medicaid program. In the case of Medicaid audits, it is currently Medicaid payers and contracted auditors who establish the parameters and best practices for the dental profession on satisfactory and complete documentation. Critiques and evaluation of dentist's chart entries during an audit are often completed by Medicaid auditors with no dental background. At times, this results in inaccurate, and even unjust, assessment of the quality of a dentist's documentation. Exasperating the issue, some dentists have not received adequate instruction on documentation which reduces risk-exposure and increases Medicaid compliance.

## Board of Dentistry focusing on infection control

The Board of Dentistry has established an Infection Control Committee to review and update the infection control checklist used for office inspections. The committee will use the Centers for Disease Control (CDC) *Guidelines for Infection Control in Dental Health-Care Settings – 2003* as the basis for its new inspection checklist. The CDC document has been adopted by the ADA as the standard for dental practices.

“I urge all dentists and their staffs to review the CDC recommendations and spend the necessary time to review their infection control protocols, said Dr. Kevin Miltko, a member of the committee.

According to the CDC, transmission of infection is rare, but continues to occur in the dental setting. In September, seven children were hospitalized for oral cellulitis after visiting a dental clinic in Southern California. It is important that all dental health care personnel understand and follow infection prevention recommendations.

When an infection occurs in the dental setting, investigators often find that proper infection prevention practices were not used. In December 2003, CDC published a comprehensive and evidence-based resource for infection prevention recommendations in the dental office, developed to protect both dental staff and patients.

A CDC review found the guidelines to still be the standard of care, but there were documented occurrences of inconsistent compliance with recommended infection

prevention practices. The 2016 *Summary of Infection Prevention Practices for Dental Settings: Basic Expectations for Safe Care* provides tools and resources to help dental staff adopt and follow appropriate infection prevention procedures described in the guidelines.

This resource includes:

- **A summary** of basic infection prevention recommendations for the dental settings
- **Links** to references and additional resources
- **An adaptable checklist** to evaluate how well dental staff are following the guidelines
- **New recommendations** relevant to dentistry that CDC published after 2003.

The ADA offers “*The ADA Practical Guide to Effective Infection Control*”, a training program for dental offices. The 40-minute DVD and workbook includes the 2016 CDC guidelines on respiratory hygiene and cough etiquette in dental practice settings. This easy-to-navigate resource covers:

- Principles and fundamentals of infection control
- Actual clinical procedures
- The difference between sterilization and disinfection

on how this issue has affected your practice and patients, please contact the MDA.

**Teledentistry** (LC0527) – MDA legislation sponsored by Sen. Caferro

Why it’s important: The MDA will require third-party payers to reimburse dentists for covered services, such as diagnosis, delivered remotely through telemedicine.

**Medicaid overpayment audits** (LC0819) – MDA legislation sponsored by Sen-Elect Albert Olszewski (R-Kalispell)

Why it’s important: In 2015 MDA sponsored legislation to create fair and reasonable standards for Medicaid overpayment audits that will protect providers while still ensuring overpayments are recouped. MDA led the healthcare provider coalition that resulted in nearly

A major benefit to the profession, and to ADA/MDA members, would be the development of example clinical chart entries for use by dentists to increase and support quality documentation in dental records. A clinical chart entry for a Medicaid insured patient must always include a justification, and supporting documentation, of why the intervention was “medically necessary”. This is a puzzling and unfamiliar term for dentists, but correlates to the diagnosis or clinical rationale, and includes a description of the clinical findings and how they were determined (i.e. radiograph, visual, tactile).

The development of example clinical

chart entries by the ADA, instead of outside third parties, promotes the unbiased and accurate assessment of dentist documentation as it is the profession articulating the best practices in documentation instead of outside organizations with little to no knowledge on such topics.

In addition to national leadership on this topic, the MDA Council on Dental Health and Health Planning also recently completed a major revision of the MDA’s BrightSmilesMontana.com website. This revision includes an instructional video on Medicaid compliance best practices, including guidance AbCd Montana reimbursement.

unanimous passage of HB 237, only to see it vetoed by Gov. Bullock. MDA will again attempt this legislation. At the same time, MDA is proposing draft rules to DPHHS to address some of the audit problems that have been identified, including allowing peers to review adverse audit findings involving clinical judgment and limiting use of extrapolation in determining overpayments due from providers.

### **Donated Dental Services** – MDA legislation sponsored by Sen. Caferro

Why it’s important: Montana’s Donated Dental Program has resulted in more than four million dollars in dental services donated by dentists for low income patients over the past 20 years. The program coordination is funded by DPHHS, but the expense exceeds the amount of that funding. MDA is seeking an additional \$20,000 annually to address the shortfall and to enable coordination of care for more needy patients on waiting lists.

### **Hygienist local anesthesia under general supervision** (LC0657) – Montana Dental Hygienist Association legislation requested by Sen. Nels Swandal (R-Wilsall)

Why it’s important: MDA is reviewing legislation that would allow dental hygienists to administer local anesthesia under general supervision.

### **Limited Prescriptive authority for hygienists** (LC0657) – Montana Dental Hygienist Association legislation requested by Sen. Swandal

Why it’s important: MDA’s Government Affairs Committee is reviewing this legislation that would allow hygienists limited prescriptive authority for preventive procedures under general supervision. The committee will offer recommended language for this bill.

### **Supervision of professional and occupational licensing boards** (LC392)

Why it’s important: The Department of Labor and Industry (DLI) is proposing legislation to require rules and actions of licensing boards, including the Board of Dentistry, to be reviewed by the DLI Commissioner for possible restraint of trade. The bill is in response to a 2015 US Supreme Court ruling upholding the Federal Trade Commission’s case against the North Carolina Board of Dental Examiners, which found that a rule that prohibited non-dentists from providing teeth whitening was a restraint of trade. The court said that licensing boards have immunity from restraint of trade when an action is pursuant to expressed public policy (such as protection of public health and safety) if that action is reviewed by a supervisor (in this case the DLI Commissioner) who can approve or veto the board action. MDA has concerns with the restrictions this places on boards to regulate licensees. MDA created a coalition of associations representing physicians, optometrists, CPAs, dental hygienists, chiropractors and other professions and occupations to address those concerns through amendments to the bill written by MDA’s legal counsel.

### Coverage for dental services under Medicaid expansion

Why it's important: More than 60,000 low-income adult Montanans have enrolled under Montana's Medicaid expansion program. MDA lobbied in the 2015 Legislature for inclusion of dental care in the expansion program and many low-income adults have benefited from timely oral health services. Implementation of the expanded dental program, which has an annual maximum limit of \$1125, has been frustrated by an outdated Medicaid claim system. MDA has lobbied to fix this problem. Medicaid

dental services for adults are optional for states and always threatened by state budget concerns. MDA will continue to advocate for Medicaid services for qualified disabled and low-income adults.



“Member value was a common thread in most all of our discussions,” said Dr. Hadnot. “The ADA fully recognizes that we need a growing and vibrant membership to remain valid as an organization.”

“The most important issue the House decided was to engage in a three-year marketing program to promote dental care,” said Dr. Newman.

Dr. Lindemann, a member of the ADA Council on Communications, calls the program “an unprecedented plan designed to address membership concern about busyness issues in their practices.” As he explains “this multiple year \$18.3 million program will use digital media

to target specific healthcare consumer groups, educating them and ultimately driving them to ADA member dental offices across the country.”

“The plan is comprised of four parts: First, a redesign of the ADA “Find a Dentist” online tool and then paid search advertising to ensure ADA members appear first when prospective patients are searching online for a dentist. Second, a nationwide digital and social media campaign that will drive patients to member offices. Third, matching funds for state and local societies that want to amplify local patient promotion efforts. Fourth,

MDA delegates led in several other areas. Dr. Gillette presented a resolution to direct the ADA to create sample chart entries members can use to improve documentation for claims submission. The measure was referred to an ADA council for follow-up (see Dr. Gillette's Leadership column on Page 2 for a complete report). Dr. Hadnot introduced a resolution to address the concerns of some members about the accuracy of the assessment of need used to allocate funding for community health centers. Although recognized as a problem, the resolution was not adopted.

The House also approved revised guidelines for administration of moderate sedation, amendments to the Code of Ethics regarding specialty announcement and limitation of practice, and recognition of Operative Dentistry as an interest area in General Dentistry.
