Considerations for performing frenectomy

A common concern that many parents have is a child with a gap between their front teeth and a large muscle attachment between them. The question of how and when to deal with a prominent maxillary labial frenum and central diastema depends on dental development.

Typically it is unnecessary to do a frenectomy for a patient that still has deciduous maxillary incisors. Often the diastema will be reduced as permanent teeth erupt, and the frenum attachment will sometimes be torn and repositioned naturally through normal play. If a large frenum and diastema persist after eruption of permanent incisors it is best to close the space first with orthodontic

force and then do the frenectomy as needed after space closure. If the frenectomy is done before space closure there is a risk that scar tissue will develop making space closure and retention difficult. Also, soft tissue esthetics are better when a frenectomy is done after space closure, as care can be taken to preserve an appropriate papilla and avoid a “black triangle” between the central incisors. In summary, wait until permanent incisors are present and then close space first and perform a frenectomy second, if necessary.

Managing the challenges of student debt

One of the more unpleasant surprises after graduating dental school is the amount of your monthly student loan repayment. Now, student loans are much more substantial, even accounting for inflation. It's a widespread issue for college graduates, but for many dental school graduates, it's an onerous burden.

The good news is that there are excellent ways of managing this debt, in a way that will allow you to thrive in your personal life and dental career.

- Know your loans. Get a firm grip on exactly how many loans you have, what types of loans they are, and who is the loan servicer. The loan servicer collects the monthly payments and is the 'go to' entity you will need to contact to take advantage of lower monthly payment programs, deferrals, and other hardship situations. Make sure to have the name and contact information of the loan servicer for each loan that you have.
- Pay your loans on time. Why? Late payments can significantly affect your credit rating. This rating in turn

will determine the rates on future loans for mortgage, practice, and equipment purchases. A lower rate will save you thousands (often tens of thousands) of dollars in interest payments.

- Check your credit report. There are three major credit reporting agencies that may have different information regarding your credit history. Look for any unknown student loans on your report. Check for any incorrect listing of missed payments or defaults. Contact the credit reporting company if you find any inaccurate reporting. If you're the victim of identity theft, this is one way to discover it.
- Take the tax deduction. Interest payments on student loans are tax deductible, up to \$2,500 (depending on your income). Tell your tax preparer about your loan payments and check to see that it's listed on your 1040 tax return. If you miss it, you may lose it.
- Automatic payments. Some loan servicers will reduce the interest rate on your loan up to 0.5% by arranging for

Medicare plan Part D opt-out extended

The Centers for Medicare & Medicaid Services has delayed enforcement of the Medicare Part D prescriber enrollment requirement to June 1, 2016.

ADA continues to seek a legislative repeal of the requirement that dentists who treat Medicare beneficiaries enroll in or opt out of Medicare to prescribe medication to their qualifying patients with Part D drug plans. Meanwhile, CMS once again delayed enforcement of the provision.

According to ADA Council on Dental Benefits, dentists must either enroll or opt in order for prescriptions they

write for patients to be covered by Medicare Part D. Dentists must submit their application at least 90 days before this date.

This rule will require Part D plans to cover a "provisional supply" of up to 90 days of a medication prescribed by a dentist who has not enrolled or opted out. After covering the provisional supply and providing the notice to the beneficiary, Medicare will reject future claims for the same medication from that dentist.

A dentist who has already opted out can revert that decision within 90 days.

Dr. Robert Miller soars above trials

Teddy Roosevelt noted that "Nothing in the world is worth having or worth doing unless it means effort, pain, difficulty...I have never in my life envied a human being who led an easy life. I have envied a great many people who led difficult lives and led them well."

Dr. Robert Miller is a retired Billings dentist. His story is truly one Roosevelt would have envied.

As an undergrad at MSU, Bob excelled on the basketball team, was named to the Rocky Mountain Conference team and inducted into the MSU Hall of Fame. He graduated from dental school at Washington University - St. Louis in 1956, married Janet Galloway that year and served as an Army dental officer in Japan. He came home to Montana and opened his practice in Hardin in 1958 and then moved to Billings to practice for another 22 years. Bob and Janet raised three children during that time and Bob was quite active in civic groups and community boards.

In 1979, Bob, who was right-handed, severed the four fingers of his right hand in a woodworking accident. He was forced to take four months off work to allow his hand to heal. Bob could have quit dentistry, but he set his



mind to improving his left hand skills and returned to practice. Soaring above this trial, Bob excelled, so much so that he received the Montana Dental Association Clinical Excellence Award from his peers in 1992.

Bob's wife Janet died of cancer in 2006 and he is now married to Linda, whose husband died of cancer in 2001. They reside in Roundup where Bob has started a new career in ranching. His hobbies have included building a harpsichord, sailing from Mexico to Hawaii, and building two airplanes. And yes, Bob still flies at the age of 84 and is a member of UFO (United Flying Octogenarians).

We all encounter trials as we journey through life and it is helpful to have role models whose lives can be observed and used to inspire our own efforts in times of trouble.

Take a moment to think about Dr. Robert Miller when you encounter your next trial, and fondly look forward to your future hopes.

MDA pushing Medicaid audit rule

MDA's fight to reform the state's Medicaid audit practices continues, even though Governor Bullock vetoed House Bill 237 after it overwhelmingly passed the Legislature.

"Getting the Legislature and Governor to focus on the concerns healthcare providers have with Medicaid audits was a major accomplishment for the Montana Dental Association," said MDA Government Affairs Committee chair Dr. Kurt Lindemann.

In his veto message the Governor directed DPHHS to implement new rules providing greater clarity and certainty in the overpayment auditing process.

"The legislative process was just the first half of the game," Dr. Lindemann said. "We now have more work to do through the state rule-making process."

MDA continues to be the lead Montana healthcare organization on this issue. Your association organized a coalition of other major Montana health associations, including hospitals, physicians, mental health providers, and other small healthcare providers to lobby during the session for HB 237.

That group will now push for state rules that can accomplish much of what was in HB 237. MDA has organized meetings to outline provider proposals for rules with the Governor's office and DPHHS senior staff. HB 237, sponsored by Rep. Al Olszewski (R-Kalispell)

called for reasonable standards for Medicaid audits, including limits on requests for records and the amount of time to complete audits. It would have required peers to review audits and would have prohibited use of extrapolation to determine the amount of overpayments recovered.

HB 237 had a long, convoluted path through the Legislature, hitting almost as many steps as a bill can, according to David Hemion, MDA executive director. It passed key committees in both houses, passed on the floor of both house nearly unanimously, and was passed by appropriations committees in both houses.

It was amended in committees and on the Senate floor and finally sent to the Governor. He replied with an amendatory veto to make changes to the bill. The House rejected his amendments on a vote that saw the positions of Democratic legislators turn from support to opposition. The bill returned to the Governor and he vetoed it again. Since the session had already adjourned, legislators voted by mail on the question of overriding his veto. The vote failed the two-thirds majority required to override.

"Thanks to all MDA members who took time to support HB 237 with contacts to legislators," Dr. Lindemann said. "If we don't get rules to protect dentists from unfair audits, we'll be back in front of the 2017 Legislature with a new bill."

Dental benefits in "Medicaid Expansion"

With much debate and maneuverings the Legislature passed SB 405, a compromise Medicaid expansion bill sponsored by Sen. Ed Buttrey (R-Great Falls). MDA played the key role in ensuring that it included dental benefits. The association is now working with DPHHS staff to define a dental benefit package that will be an improvement over current services. The bill requires

recipients to pay a cost of the insurance premium and to make co-payments for healthcare services. It also includes workforce development measures to assist recipients to move into employment that will lift them out of Medicaid. A federal Medicaid waiver is necessary before healthcare provisions of the bill can be implemented.

MDA members lobby Congress

Delegates discuss legislation with DC Reps

In April, MDA leaders traveled to Washington to voice dentistry's positions on student loan reform, MDA's efforts on Medicaid audits, funding for oral health education and prevention, and improvements to federal savings accounts with Montana's congressional delegation. Drs. Kevin Miltko, Mike Bowman, and Doug Hadnot held face-to-face meetings with Senators Tester and Daines and Representative Zinke during the ADA's Washington Leadership Conference.

"We were able to start forming the valuable relationship it takes to be able to be a resource for them," said Dr. Bowman. "Establishing these friendships will build rapport and trust which we will leverage for our patients and our association."

"We discussed issues with student debt and making it easier to lower interest rates for these loans," he said. "We advocated for allowing student loans to be refinanced more than once to be able to take advantage of low interest rates."

Dr. Hadnot spoke to H.R. 539 - Action for Dental Health Act of 2015. The bill, proposed by the ADA, would

fund grants to organizations for oral health education, prevention, and outreach to establish dental homes for children and adults with special needs.

"We have so many of these efforts going on in Montana, including Sealants for Smiles, Donated Dental Services, Give Kids a Smile Day, the Shepard's Hand Clinic in Kalispell, The Veterans program in Great Falls, and our MDA prevention and awareness program," he explained to the delegation.

"They were especially interested in MDA's legislative effort to reform the RAC audits," said Dr. Miltko. "All are supportive of RAC Audit Reform."

The MDA group also discussed the RAISE bill, co-sponsored by Congressman Zinke, to improve Federal Savings Accounts (FSAs).

"This bill would allow FSAs to be more like Healthcare Savings Accounts (HSAs)," Dr. Miltko explained. "It would raise the annual FSA limit to \$5000 and allow all unused funds to rollover to the next year or used as needed. It would allow \$500 per dependent per year for FSAs for families having more than two dependents."

auto payments, where the monthly payment is transferred from your bank account. This can save you money and may help your credit rating by reducing the chances of late or missed payments.

- **Income-based repayment plans.** These are for federal student loans, which account for over 90% of all student loans. This can provide relief for dentists with large loan balances. The monthly payments are based on either your earnings or total income, which results in potentially much lower payments than with the standard ten year repayment period. The other outstanding feature is that any remaining loan balance is forgiven after 20 years of payments (25 for some programs). Is there a catch? Yes, the total amount of interest you'll pay over the course of the loan will likely be higher, perhaps much higher. So is income-based repayment for you? This is when you should consider all the other aspects of your financial life. You may want to review the choices with your financial advisor.

- **Public Service Loan Forgiveness (PSLF).** The PSLF Program is intended to encourage individuals to enter and continue to work full-time in public service jobs. Under this program, borrowers may qualify for forgiveness of the remaining balance of their Direct Loans after they have made 120 qualifying payments on those loans while employed full time by certain public service employers. More information about what loans are eligible for forgiveness under this program and what employers qualify can be found on the Federal Student Aid website.

We've discussed several ways to manage student loans. Some can have many confounding details. Make sure to carefully research the details of any payment plan you are considering. You can also consider speaking to your financial advisor regarding consolidating loans, tax issues, matters involving your credit rating, and strategies regarding which loans to pay off first.

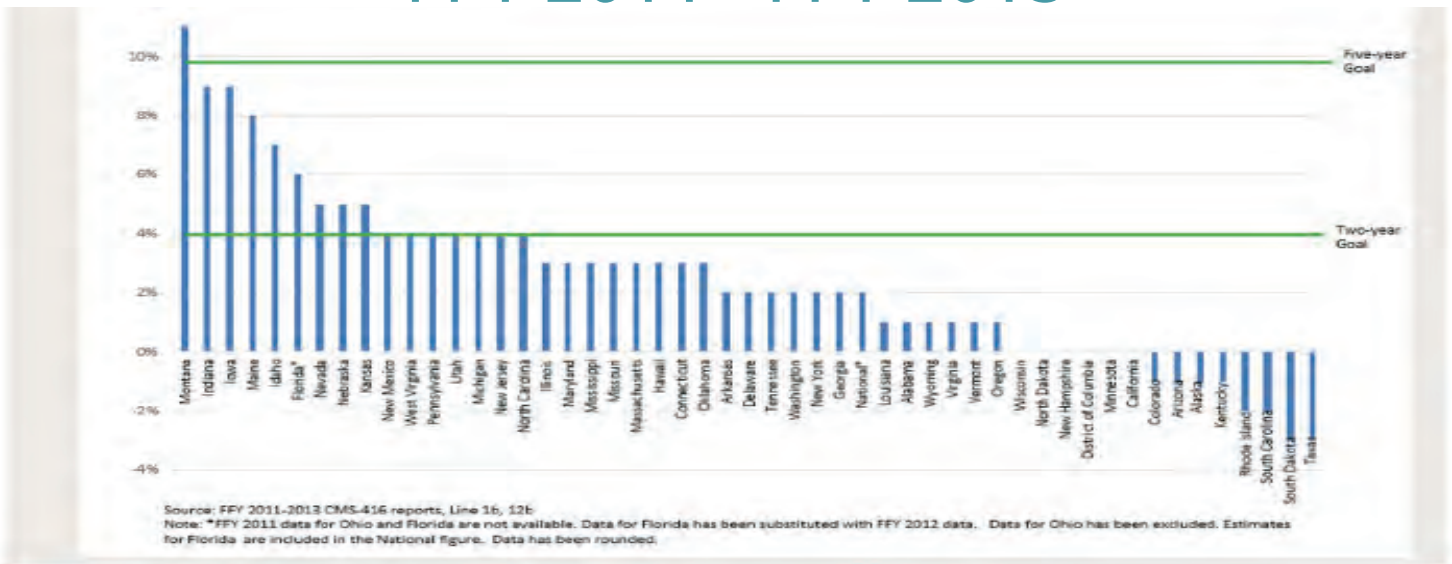

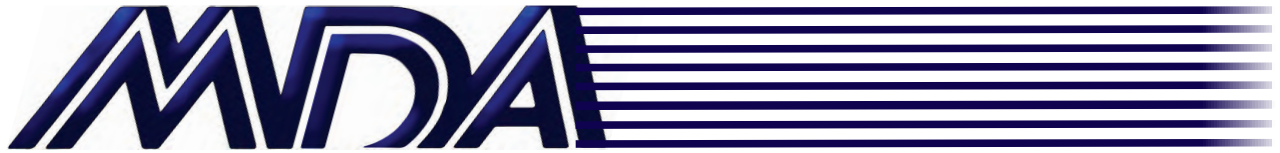
