## We need a strong Montana Dental Association

Dentistry is constantly under attack from outside forces. We need our association to protect dentistry and helps us succeed.

Recently, I had a patient's father come by who works as a physical therapist. I asked him about his business. He responded that it was becoming harder and harder to be a physical therapist in the current environment. One of the largest employers in his community changed their insurance policy for their employees. The new insurance plan would only cover physical therapy patients who sought treatment at a specific office. This has caused a dramatic loss of patients for my physical therapist friend. I asked him what his physical therapist association had done to help with this unfair situation. He said that their association has done nothing. He commented that their association was so weak and fragmented that it was powerless to advocate for change. I was shocked at this, and told him to get involved and create change. He informed me that it was too late. The physical therapists had neglected their association, and a culture of apathy had set in. There was nobody to help advocate for his profession.

A few months ago, I had lunch with a medical colleague from Great Falls. I asked him how his practice was doing. He responded that his practice is slower than ever. The government regulations and extra bureaucracy are negatively impacting his practice. He said he is working more hours than ever before, but making significantly less money. He is considering closing his practice, and taking an early retirement. I asked him what his professional association is doing to help him and his colleagues improve their tough situation. He responded that they were doing very little. Their association is weak and fragmented. It was unable to create the needed change. There was nobody advocating for his profession.

# NEWS YOU CAN USE

## Tobacco cessation counseling

If you are not doing it already, here are two reasons to start

### Dr. Jason Tanguay

Mark Twain once said, "Quitting smoking is easy. I've done it a thousand times." Hopefully it won't take your patients that long, but it is a difficult road and they need all the help they can get, including you and your dental team.

**Reason #1 - Their health:** In addition to being detrimental to oral health there are many documented risks to overall health. You could save your patient's life!

**Reason #2 - You can get paid for it:** ADA code D1320 (Tobacco counseling for the control and prevention of oral disease) is something you can bill for and Montana Medicaid currently reimburses this code at \$37.16.

How do you do it? Ask, Advise, Assess, Assist and Arrange. In my office, my team members will usually ask (if patient is using), advise (education about health risks), and assess (inquire if the patient is interested in quitting).

The assist and arrange is done in conjunction with the Montana Tobacco QuitLine (1-800-QUIT-NOW). We fax in a referral (available at [montana.quitlogix.org](http://montana.quitlogix.org)) and they take it from there following up with the patient and providing them with resources to help them Quit!

### ASSIST AND ARRANGE - TOBACCO CESSATION

#### Ask

Tobacco use (current, former, never) is a vital sign. Chart patient response.

#### Advise

Give clear, strong, personalized advice to quit. "Quitting tobacco is the most important thing you can do for your health. I will help."

#### Assess

Is the tobacco user willing to make a quit attempt at this time? "Are you ready to try to quit tobacco?"

- Yes – Help the patient create a quit plan
- No – Enhance the patient's motivation to quit

# Advocate

## The session is over



The 2017 session of the Montana Legislature adjourned sine die on April 28, leaving follow-up work for the MDA as it addresses rulemaking on important affecting dentistry issues. From a new wave of bills attempting to control healthcare costs by changing patient behaviors, to expanded scope of practice for dental hygienists, 2017 was a challenge which the MDA met head on

“We had an incredible session. One of the best ever,” said Dr. Kurt Lindemann, Government Affairs Committee chair. “MDA pulled together a great advocacy team; Government Affairs Committee, grassroots dentists, lobbyist, attorney and executive director.”

Here’s a summary of what happened in the Legislature, why it’s important, and what’s next.

### **Prescribing authority for dental hygienists; local anesthesia under general supervision**

SB 120, sponsored by Sen. Nels Swandal (R- Wilsal) at the request of the Montana Dental Hygienists Association, was enacted and allows dental hygienists to prescribe drugs limited to fluorides, topical anesthetics, and nonsystemic antimicrobials. The Board of Dentistry will now begin writing rules to implement prescribing authority, including hygienist education and competency requirements, as well as percentages of active ingredients in drugs that are prescribed. Hygienists cannot begin prescribing until the Board of Dentistry adopts rules.

The bill also allows dentists to delegate local anesthesia under general supervision. Those provisions in the bill are now in effect.

### **Teledentistry**

The legislature passed SB 129, a bill requested by MDA and sponsored by Sen. Mary Caferro (D-Helena), to require third-party reimbursement for dental services delivered through teledentistry. This will include dentistry in a statute covering other healthcare providers. A dental offices or other provider can transmit diagnostic data, such as patient x-rays and intraoral video, to a dentist in another location to diagnose and prescribe treatment. The bill goes into effect on January 1, 2018.

### **“Transparency/Shoppable Healthcare”**

Republicans and Democrats pushed for new statutes to regulate providers and insurers in an effort to control the cost of healthcare. “Transparency” mandates require insurers and providers to give patients more data about the cost and quality of treatment. Some believe that armed with additional information, patients will change their behaviors and choose lower cost treatments, resulting in savings to patients and to employers paying for health insurance. premiums.

From the perspective of providers, especially dentists and other small practices, the four transparency bills in the 2017 session created difficulties and MDA led a successful effort to exempt small practice providers from transparency mandates.

At the close of the session, SB 362 by Senator Ed Buttrey (R-Great Falls) was the only bill to pass, but was then vetoed by Gov. Bullock. The Legislature is voting by mail on a motion to override the Governor’s veto. A resolution passed by the House will require the Economic Affairs Interim Committee to conduct a study of transparency in healthcare costs and report to the 2019 legislative session, so the issue remains a removing target going forward.

### **Medicaid audits**

The Legislature passed SB 82, the bill sponsored by Sen. Albert Olszewski (R-Kalispell) and requested by MDA, to set fair and reasonable standards to reform

## Assist

Help create a quit plan.

- Set a quit date within two weeks
- Review past quit attempts
- Avoid other tobacco users
- Tell family and friends
- Remove tobacco from home, work, and car
- Avoid alcohol

Recommend or prescribe pharmacotherapy.

Enhance motivation to quit.

- **Relevance** – Ask the patient why quitting is personally relevant

- **Risks** – Ask the patient to identify consequences of tobacco use
- **Rewards** – Ask the patient to identify benefits of quitting tobacco
- **Roadblocks** – Ask the patient to identify barriers to quitting and ways to circumvent them

Refer to tobacco counselor, telephone quit line for help.

## Arrange

Schedule in-person or phone follow-up, offering reinforcement and encouragement.

Medicaid audits. Since 2014, MDA has led the coalition of providers lobbying for audit reform. Similar legislation was vetoed by Gov. Bullock in 2015. In this session, Sen. Olszewski worked with DPHHS and the coalition to pass a bill which the Governor has now signed. It limits record requests and look back periods for Medicaid audits and allows providers to request peer review of clinical issues when an adverse decision is made. These provisions remove concerns some providers have in serving Medicaid patients. MDA will monitor DPHHS rulemaking as it implements the bill. MDA members are urged to contact the Association, if you are audited and have concerns.

## **Medicaid dental program**

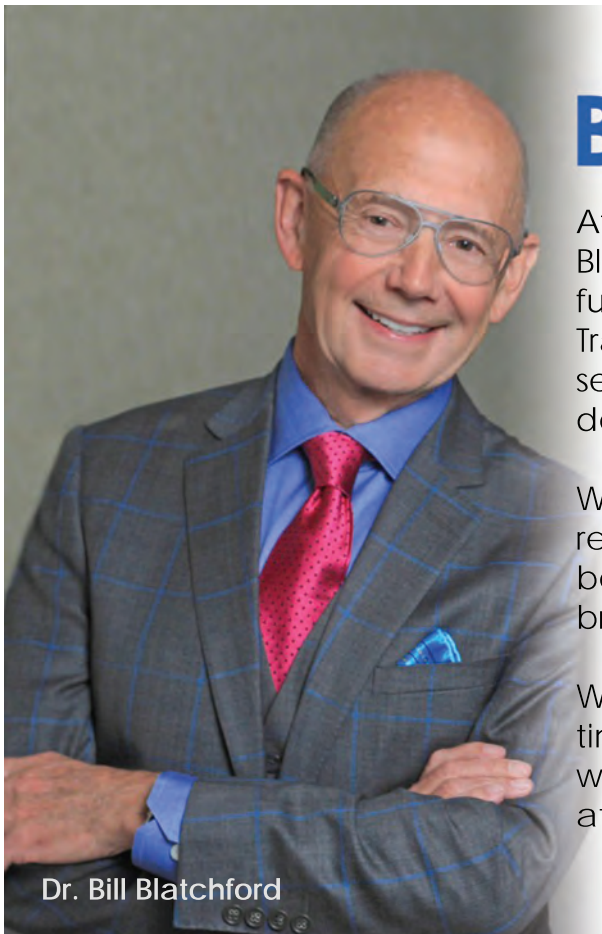
MDA opposed reduction in funding for dental Medicaid. The budget passed by the Legislature reduced funding to DPHHS, but allows the department flexibility in making those cuts. A projected shortfall in collection of income taxes will trigger reductions across all state government funded programs. MDA will continue to work with DPHHS to ensure those reductions do not fall on dental services.

## **General supervision for dental assistants**

The Senate Business, Labor, and Economic Affairs Committee tabled SB 80, the bill sponsored by Sen. Steve Fitzpatrick (R-Great Falls) to allow some assistant functions to be delegated under general supervision of the dentist. MDA will continue work on this issue in preparation for the 2019 session.

Looking into the future, Dr. Lindemann is optimistic. "I'm certain we will continue our momentum into the next session in 2019. In preparation, MoDePAC (the Montana Dental Political Action Committee) will have work to do for the 2018 election. Stay tuned on how you can help your profession remain strong in protecting you and your patient's autonomy in care decisions and maintaining a business environment that will foster that goal."
